### **OFF-LICENCE**

Sections 17 to 20, 40, 64, and Section 127(2), Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012 Y's Corporation Limited is authorised deliver alcohol from the premises situated at 140 Dakins Road, Gladstone, Carterton, and known as Urlar Winery, to any person for consumption off the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with subpart 7 of Part 2 of the Act

#### CONDITIONS OF LICENCE

Alcohol may be be sold on and delivered from the premises for consumption off the premises, or supplied free as a sample for consumption on the premises only during the following days and hours:

# Monday to Sunday – 9:00am to 10:00pm

- No alcohol is to be sold or delivered from the premises on Good Friday, Easter Sunday, Christmas Day or before 1:00pm on ANZAC Day. (b)
- No alcohol is to be delivered on Easter Sunday unless the alcohol is grape wine or fruit, or vegetable wine made: (c)
  - on the premises; or
  - from grapes or fruit harvested from land on which the premises are situated.
- (d) Drinking water is to be freely available to customers while alcohol is being smapled free as a sample, from the location at which the sampling
- A properly appointed certificated or acting of temporary manager must always be on duty, within the licensed are awhen the premises are open (e) for the sale and supply of alcohol, and their full name must be on a sign prominently displayed on the premises.
- The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must (f) display:
  - at every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.
  - at the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for the sale of alcohol.
  - a copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.
- A remote sale of alcohol may be made at any time on any day (g)
- The licensee must ensure that any alcohol sold by remote sale is not delivered to the buyer (or to any other person on the buyer's behalf) at any (h) time after 11.00pm on any day or before 6.00am on the next day. Whether the alcohol is delivered by the seller or some other person.
- The licensee must follow the procedures set out in Regulations 14 of the Sale and Supply of Alcohol Regulation 2013 to ensure that neither the purchaser nor the person to whom alcohol is delivered is a minor.
- All deliveries of alcohol must be signed for a person aged 18 years or over.
- the licensee must display on its website and/or catalogues and on every receipt issued for alcohol sold remotely. (k)
  - The licence holder's name and licence number.
  - The date on which the licence expires. ii.
  - A legible image of the licence or a clearly identified link to such an image. iii.

## THE LICENSED PREMISES

The premises, situated at 140 Dakins Road, Gladstone, Carterton are more precisely identified as outlined in a plan date received by the Carterton District Licensing Committee on the 31st July 2023.

# DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from 140 Dakins Road, Gladstone, Carterton is designated as the principal entrance.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- Until the close of the period of 3 years commencing with the date of its issue; or (a)
- If an application for the renewal of the licence is duly made, until the application is determined; or (b)
- If the licence is renewed, until the close of the period for which it is renewed.
